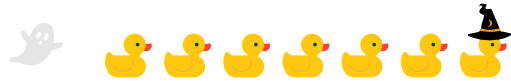

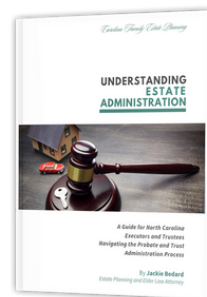


3. Shifts Liability

PUMPKIN MUFFINS

Try these easy-to-bake cinnamon spiced pumpkin muffins as a mid-morning snack. They're ideal for Halloween and Bonfire Night, too!

Ingredients:

- 8 oz plain flour
- 2 tsp baking powder
- 1 tbsp ground cinnamon
- 3½ oz caster sugar
- 2 oz soft light brown sugar
- 7 oz pumpkin purée
- 2 large eggs
- 14½ oz salted butter, melted

Directions:

1. Heat the oven to 400°F. Prepare a 12-hole muffin tin by lining it with muffin cases. Mix the flour, baking powder, cinnamon, and both sugars together in a large bowl. Break up any lumps of brown sugar by rubbing them between your fingers.
2. In a separate container, whisk together the pumpkin puree and eggs. Incorporate this mixture into dry ingredients along with the melted butter until well combined.
3. Bake for approximately 15 minutes, or until the muffins are beautifully golden and have risen and a skewer inserted comes out clean. Lift onto a wire rack to cool completely.

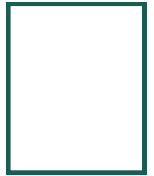

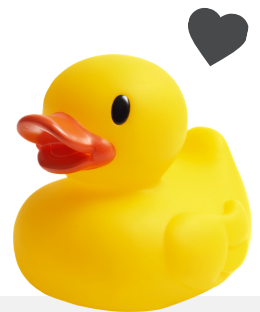
